

FIREFIGHTERS' PENSION SCHEME 2015: ELECTION TO REPAY PENSION CONTRIBUTIONS FOLLOWING A PERIOD OF ABSENCE WITHOUT PAY

Treatment of contributions during absences

The Firefighters' Pension Scheme 2015 (FPS 2015) is one of the best ways to plan for retirement, with an excellent range of benefits which all members can enjoy. As the benefits are based on your pay, certain unpaid absences from work can have an impact on your benefits.

If you are absent from work, for any of the following reasons, your lost pay will not be included for pension purposes, resulting in a lower pension value being calculated for the year(s) that the period occurred:

- Absence due to illness or injury, with no entitlement to pensionable pay (including statutory pay)
- Absence following a trade dispute
- Authorised leave of absence (of up to 5 years)

You can, however, elect to repay the contributions due on the pay you would have received, had it not been for the absence. This notional pay is known as '**assumed pensionable pay**'. You will have 6 months **from your return to work following the absence** to repay your contributions and benefit from the inclusion of 'assumed pensionable pay'. You will pay the same percentage rate that you were paying before the absence.

Please note, your employer may require you to pay their contributions that would have been paid during the absence as well as your own.

Child-related absences that relate to additional maternity leave, additional adoption leave, parental or shared parental leave, where the member is not entitled to pay (including statutory pay), can also elect to repay the contributions due on 'assumed pensionable pay'. For this scenario, you will have 30 days **from your return to work following the absence** to repay your contributions and benefit from the inclusion of 'assumed pensionable pay'. You will pay the same percentage rate that you were paying before the absence.

What happens to my benefits if I don't repay the contributions due?

If you don't repay the contributions due on '**assumed pensionable pay**', your pensionable pay will be reduced, meaning that your pension will be directly affected.

Not all absences require you to make this election

Absence due to illness or injury where some / all pensionable pay (including statutory pay) is received requires

- the member to continue paying their normal rate contributions on the actual pay received
- Absence due to reserve forces service leave requires the member to continue paying their normal rate contributions on the lesser of '**assumed pensionable pay**' and actual pay received and any additional payment
- made by your Fire & Rescue Authority
- Child-related absences that relate to ordinary maternity leave, paternity leave or ordinary adoption leave, where the member is not entitled to pay (including statutory pay) during the period of absence, is treated as
- having paid their contributions due
- Child-related absences that relate to ordinary maternity leave, paternity leave or ordinary adoption leave where some / all pensionable pay (including statutory pay) is received requires the member to continue paying their normal rate contributions on the actual pay received
