## 2011/12 Council Tax Leaflet

#### **Home Safety**

East Sussex Fire & Rescue Service can provide FREE home safety advice and FREE smoke alarms to help those at greatest risk. People most at risk from fire are the elderly, particularly those living alone, single parent families and people with reduced mobility, hearing or sight impairment.

If you consider yourself to be at risk for any of these sorts of reasons, your local Fire & Rescue Service staff are available to visit your home to discuss fire safety issues with you.

They will also ensure that you have working smoke alarm(s) in your home and where you do not, they will supply and fit smoke alarms.

In the first nine months of 2010/11, we completed over 8,100 home safety visits and fitted more than 10,300 smoke alarms in people's homes. But we still had to attend nearly 1,100 primary fires.





#### **Message from the Chairman**

I am pleased to introduce East Sussex Fire Authority's Council Tax leaflet for 2011/12.

The following pages give some explanations about our costs including how we are funded and how our costs have changed from 2010/11. Information is also provided on what we have achieved during the year and our aims for the future.

This Authority supports Value for Money, which is all about providing quality services to the standard that the community expects, and at a

price that you, as council taxpayers, are prepared to pay.

Our Service will cost council taxpayers £81.86 for the year 2011/12 which is unchanged from 2010/11 (Band D property). It has only been possible to achieve this council tax freeze because the Fire Authority has made budget cuts of £0.653m in 2011/12 to offset reductions in general Government Grant. However, the Government is also providing a temporary grant to any authority agreeing to freeze council tax in 2011/12 and this has also helped to achieve the same level of precept as in 2010/11.


